## NOTIFICATION

## **GUJARAT POLICE ACT, 1951**

No.A-2/Cyber Crime Police Stn/ 1642 /2018

Dated 3a10.2018.

- 1. As per the notification No.PRS-5459/89.V dated 11.04.1960, under Bombay Government Gazette, the Detection of Crime Branch, Ahmedabad City has been notified as a Police Station.
- 2. The Government of Gujarat, Home Department, vide its Notification No.MAHAK/1008/224/S dated 28.03.2008 has accorded sanction for starting a Cyber Cell in the Detection of Crime Branch, Ahmedabad. Accordingly this office, vide its office order No.A-1/747/Badal/5538/08 dated 26.9.2008 has started a Cyber Cell within the DCB.
- 3. In exercise of the powers conferred by Gujarat Police Act, Rule 12, I, A.K. Singh, IPS, Commissioner of Police, Ahmedabad City do hereby bifurcate the workings of Detection of Crime Branch Police Station of Ahmedabad City and declare creation of a Cyber Crime Police Station which shall become functional with effect from 31.10.2018 At 00.00 hours.
  - (i) The Cyber Crime Police Station will have its jurisdiction over the entire Police Commissionerate of Ahmedabad City.
  - (ii) The duties of the Cyber Police Station will be as under:
    - a) The Cyber Crime Police Station shall have jurisdiction in respect of all the offences committed under the Information Technology Act, 2000 and other related offences under any other law for the time being in force, committed in the course of the same transanction.
    - b) Registration of Cyber Crime cases whenever cognizable cyber crime is reported under the Information Technology Act.

- c) Investigation of cases registered at Cyber Crime PS and also those cyber crimes cases transferred to from other units.
- d) Securing witnesses and recording their evidences.
- e) Collection of Oral, Electronic, Documentary and Circumstantial evidence from the victims/witnesses/servers/ computers, online servers etc. to connect the offender to the offence.
- f) Collection of evidence/information from Internet Service Providers, Mobile Service Providers, Banks, Financial Institutions, Payment gateways, Online commercial Websites, email Service providers, social media service providers and such other sources.
- g) Preparation of letter Rogatory, Look Out Circulars, Red Corner Notices and Extradition proposals.
- h) Collection of appropriate certificates U/s. 65(B) I.E. Act.
- i) Supervision and monitoring of pending trial cases.
- j) Presenting evidence during the trial of cases.
- k) Collection of Intelligence regarding cyber crime and intelligence with law and order implications involving cyber media.
- Enquires into petition regarding commission, prevention, detection, investigation of cyber offences, incidents.
- 4. Cyber Crime Police Station will have to maintain the FIR Book, Arrest Register, Mudamal Receipt, charge Sheet Form, Crime Register and all relevant e-GujCop databases etc. as per prescribed Rules and take cognizance of complaints as per Rules 113, 114 of Gujarat Police Manual, Vol.III and take necessary action as per laws.
- 5. The investigations of such offences will be supervised by the DCP, Cyber Crime Branch, Ahmedabad City.
- 6. The general public of Ahmedabad City Police Commissionerate are hereby notified that henceforth, in case of any Cyber Crime related complaints, they may approach the Cyber Crime Police Station at Bungalow No.15,

Dufnala, Shahibaug, Ahmedabad City-380 004. In addition, all other territorial and functional police stations of Ahmedabad City Police will continue to have concurrent jurisdiction to Register and Investigate Cyber Crimes in their respective Police Station limits.
